***Note:** In case of non-availability of DBT-JNU-CEEB-2019 qualified candidates, admission will be given in preference to the ICAR-AIEEA (PG) followed by PG-CET (MAUEB) qualified candidates in Agril. Biotechnology during the year 2019-20 based on merits.

Procedure for filling-up of vacant seats of DBT-PG Programme:

1. The eligible candidates are instructed to check the available vacant seats mentioned in this circular and report personally to the V.D. College of Agricultural Biotechnology, Latur along with all necessary original documents and prescribed fees between 10.00 hrs to 13.00 hrs during 31st August 2019.
