Sub: Call for quotation – Subscription of Remote Access Software and Federated Search Software/ Engine to University Library.

Vasant Rao Naik Marathwada Krishi Vidyapeeth , University Library, Parbhani invites sealed quotations for Remote Access Software and Federated Search Software to the University Library , Vasant Rao Naik Marathwada Krishi Vidyapeeth, Parbhani. **The sealed quotation should reach on or before 19 December 2019 to the University Library.** The sealed quotation should be in favor of Librarian, Vasant Rao Naik Marathwada Krishi Vidyapeeth, and Parbhani. On the sealed envelope bold letters as ***“Quotation for Subscription of Remote Access Software and Federated Search Software / Engine to University Library”*** should be mentioned

Part- A: Nature of work

The work details are as below –

1. The IP based e-Resources available at University Library, Vasant Rao Naik Marathwada Krishi Vidyapeeth; Parbhani should be made available to the university library users at their desktop/laptop/mobile 24 x 27 via registered email ID and password provided to them.
2. The University has its seven constituent colleges situated in the Marathwada region. The library users of the constituent colleges should also be able to access the e-Resources of the University via login Id and password of the Remote Access Software.
3. There should be no restriction on the number of registration Ids and password.
4. The e-Resources made available through Remote Access Software should be accessible via mobile App developed by the Software supplying firm.
5. The mobile App developed by the Software supplying firm should have unlimited download facility via user id and password provided by the university library. (no restriction on number of downloads)

6. Federated search software should integrate the library bibliographic data with e-resources available at University Library and other useful open source resources and provide single window search facility for the library users. (The University Library is using Koha : LMS)
7. The following facilities should be made available via Remote Access Software and Federated Search Software / Engine –
 - i. **Single Point Search:** The ability to search all the available Content (Subscribed & Open) on the Library Platform including Audio, Videos, Journals, E books etc.
 - ii. **A-Z Catalogue of Resources :** Should provide comprehensive A-Z list of all Digital Holdings subscribed by Organization, physical holdings of Organization and all the Open Access Resources.
 - iii. **Personalization with “My Library”:** Personal workspace for every user to save searches, reading lists, web clips and organize research. This is synced with E-Library Mobile App to ensure seamless user experience.
 - iv. **User/Usage Analytics:** Should provide powerful reporting with complete usage and user analytics which includes sessions, no. of downloads, visits and logins, listing of all registered users, Bulk Registration of users etc.
 - v. **Self Service Administration Dashboard :** Enables administrator to – Manage the Library Content, Users and Analyze Usage . Modify the Library Portal, Navigation, Branding and Content

5. No advance payment will be released at the time of work order.

The services provider firm should not share the bibliographic data of University Library and constituent college libraries of Vasantrao Naik Marathwada Krishi Vidyapeeth, Parbhani with any other library or institution. The bibliographic data of University Library should strictly be kept confidential.
7. The firm will provide the facility of the remote access software and integrated search software / engine via exclusively designed mobile app having unlimited download facility without any restrictions.
